I. Support Information

The State of California requires that the local Board of Education of each School District review and approve unaudited actuals contained within the annual financial report (SACS Unaudited Actuals).

Components of the financial year ended June 30, 2019 are highlighted below. All numbers are still subject to external financial audit.

1. The General Fund ending balance, as of June 30, 2019, was \$10,334,017. This is shown as follows:

2. Average Daily Attendance at year-end was 6,411.64, an increase of 1.3% from the 2017-2018 school year.
3. Attached is a table showing actual revenues, expenses and fund balance information for the past three years and for the budget year 2019-2020.
4. The District met all mandated financial reserve requirements for FY 2018-2019. As of June 30, 2019, the District had a Special Reserve Fund totaling \$12,563,632 or 12.4 percent of the Restricted and Unrestricted General Fund expenditures.

The Superintendent recommends that the Board of Education approve The Annual Financial Report (SACS Unaudited Actuals), which contains the Unaudited Actuals for FY 2018-2019.

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year.
